

#### Michigan Arts and Culture Council (MACC) Grant Programs - Fiscal Year 2024

### FY24 MACC DIRECT GRANT DEADLINE: JUNE 1, 2023, 5:00 PM EST

**OPERATIONAL SUPPORT**: up to \$60,000 for operations with 1:1 cash match (tier level determined by annual budget) \*Eligible applicants must be an arts & cultural nonprofit with a minimum 3 years of \$10,000 in unrestricted funds.

**PROJECT SUPPORT**: up to \$30,000 for production, presentation, of arts and cultural projects with a 1:1 cash match \*Eligible applicants must be a non-arts & cultural nonprofit, municipality, or college/university.

**CAPITAL IMPROVEMENT**: up to \$100,000 with 1:1 cash and/or in-kind match for the expansion, renovation of arts and cultural facilities, or the purchase of equipment an (in-kind match must be new materials, in-kind labor is not eligible) \*Eligible applicants must be an arts & cultural nonprofit or municipality.

**NEW LEADERS:** up to \$4,000 request with 1:1 cash and/or in-kind match to support arts and culture related projects or collaborations led by a young person (14-30 years old) who is associated or connected to an established youth/teen subcommittee, young professionals' group, or for the formation of a new teen/youth subcommittee or group \*Eligible applicants must be a nonprofit organization, municipality, or school that hosts, facilitates, runs, or manages a youth/teen subcommittee or young professionals' group.

# FY24 MACC EDUCATION GRANT PROGRAMS (K-12)

Round 1 – August 3, 2023, 5:00 PM EST (for projects October 1, 2023 – September 30, 2024) Round 2 – January 15, 2024, 5:00 PM EST (for projects March 1, 2024 – September 30, 2024) ARTS IN EDUCATION: up to \$20,000 to fund arts education school-based arts learning projects with a 1:1 cash match (teacher/admin time directly related grant implementation & instructional time may be used as cash match) \*Registered K-12 educational institution (public/non-public/home), district, or accredited agencies are eligible to apply.

**ARTS EQUIPMENT & SUPPLIES GRANT**: up to \$1,500 for arts equipment (including repairs of arts equipment) or supplies being used within the k-12 classroom/school setting (\*Michigan K-12 teachers in any arts discipline may apply for the grant, including creative writing, dance, film/video, music, visual arts, and theatre)

BUS GRANT: up to \$500 to Michigan K-12 schools for the transportation costs of an arts or culture related field trip

# FY24 COMMUNITY PARTNERS GRANT PROGRAM

Round 1 – August 3, 2023, 5:00 PM EST (for projects October 1, 2023 – September 30, 2024) Round 2 – January 15, 2024, 5:00 PM EST (for projects March 1, 2024 – September 30, 2024) COMMUNITY PARTNERS: \$10,000 to \$20,000 to strengthen communities by encouraging them to work collaboratively with artists and culture bearers to explore cultural traditions/heritage and share in the creative process of arts and culture where the collaboration is integral to daily lives and is valued as a tool for community development. Grant award must be matched on a 1:1 basis with cash and/or in-kind services.

# FY24 MACC MINIGRANT DEADLINES:

Round 1 – August 3, 2023, 5:00 PM EST (for projects October 1, 2023 – September 30, 2024) Round 2 – January 15, 2024, 5:00 PM EST (for projects March 1, 2024 – September 30, 2024) \*Be sure to check if your region will hold Round 2 funding before starting a Round 2 application.

\*Applicants may only receive one (1) POD <u>and</u> one (1) Projects Minigrant per Fiscal Year (Oct 1 – Sept 30). **MINIGRANT PROFESSIONAL or ORGANIZATIONAL DEVELOPMENT PROGRAM (POD):** up to \$1,500 for professional development opportunities with a 1:4 cash and/or in-kind match (25% match)

\*POD grant program may be used for out-of-state travel to attend workshops, conferences, etc.

\*Eligible applicants must be a nonprofit arts & cultural organization registered in the state of Michigan <u>OR</u> individual artist, arts administrator, culture bearer, arts educator, or film professional.

**MINIGRANT PROJECTS:** up to \$4,000 for arts and cultural projects with a 1:1 cash and/or in-kind match \*Eligible applicants must be an arts & cultural nonprofit or non-arts nonprofit registered in the state of Michigan, a

K-12 school, or municipality. **NOTE:** Applicants may apply for Operational Support / Project Support / <u>or</u> Arts in Education grant <u>AND</u> Minigrant Projects but may only accept funding for one grant (if awarded funding in both).
